



# BABA Steering Committee Minutes

*January 18, 2006*

## **Present:**

## **Topics:**

1. **Incorporation** – Maureen will talk with Helen regarding the status of filing papers to Incorporate BABA.
2. **Avon N.C. Trip** – 4 houses have been reserved for the spring trip. Dates are May 6<sup>th</sup> thru 13th. Price for a private room is \$400 and shared room is \$190. We need to publicize to the membership thru email and the newsletter so that the houses are filled. Roger Jackson may be available to provide loaner equipment and sailing guidance in exchange for a shared room in one of the BABA houses. Tom Sargent will contact him to confirm.
3. **T-Shirts** – Fan is ordering 100 men's and women's t-shirts in a variety of sizes. Unit prices will be around \$7.00 and the plan is to sell them for \$10.00. Ann wants a grey women's medium.
4. **Regatta Insurance** – Tom received the following correspondences regarding regatta insurance. The cost for the package is around \$300. We decided to look into this further and reach a decision at our next meeting.

Dear Tom:

Regatta Liability is designed to defend the organization, the board members, executive officers, race committee and protest committee if a competitor is injured or dies on a race course (our definition of racing is from the time the competitors leave their mooring (beach) until they return to their mooring). This is probably the highest risk activity a club involves itself in.

The separate On-The-Beach General Liability would address a slip and fall on the land, a meeting at a members house where someone (other than the homeowner) knocks over a vase, etc. It also provides what is called "host liquor liability," where any time the organization gives liquor away freely (no donations, no \$.25/cup, etc.) and someone ends up in a car crash and BABS is sued, we would defend BABS and the board members and executive officers.
